

Supplemental Educational Services

Supplemental Educational Services (SES) are free tutoring or other supplemental academic services in reading, mathematics, and language arts provided free-of-charge to some students under the Federal *No Child Left Behind Act*.

Your child may qualify if:

- ❖ He/she receives free or reduced lunch and;
- ❖ Attends a Title I school that has been placed on CT's "in need of improvement" list for two or more years

SES are provided outside the regular school day – before or after school, on weekends or in the summer. They may be offered through public- or private- sector providers that are approved by the state. States must maintain a list of approved providers across the state organized by the school district or districts they serve, from which parents may select. It is the school districts responsibility to provide annual notice to parents of eligible children about the availability of services and information on the approved providers. If you think your child may qualify for SES, contact your child's principal or your school districts SES contact person to find out if your child is eligible.
